WHEREAS, the Officials of the Gujarat Pollution Control Board (hereinafter referred to as the Board, in short), conducted inspection on 21/02/2017 in order to verify the statements made by you in your application for Consent to Operate under the Air , Water , Hazardous Act / to ascertain the Compliances of Conditions specified in Consent Order.

WHEREAS during the inspection it was observed that:-

**Reason :**

1. Sludge is found in aeration tank no. A & B approx 3 m depth. Approx. 2500 MT dry Sludge is found in aeration tank no. C.
2. As per AR dated 07/12/16 COD: 510 mg/L, BOD: 105 mg/L. As per AR dated 30/01/17 COD: 885 mg/L, BOD: 82 mg/L. Which is more than consented norms.
