NCT invites competent and well-experienced Contractors for **Sludge Transportation from Narmada Clean Tech [NCT] - Jhagadia to BEIL**

### GENERAL PRE-QUALIFICATION (PQ) CRITERIA FOR THE ISSUE OF TENDER DOCUMENTS:

1. The vendors shall have contracts currently with 'Reputed Large Companies' All over India.
2. The vendors must have experienced during the last five years in industrial areas anywhere in India. (Provide documents evidence of experience of 5 years)
3. The vendors should provide a 'Satisfactory Service Certificate' from three of their existing major clients.
4. Total turnover of the vendor during the last three years should not be less than three times the estimated cost per year of the specific tender. (i.e. minimum 92 Lacs Estimated cost) The vendor should not have reported annual losses for more than 1 year during last three years' period.
5. The vendor should not have had any disputes with NCT and not have filed any legal cases against NCT Management & Directors currently and during last five years.
6. The vendors have to submit the following documents –
  - Audited and certified copy of last three the years' balance sheet, Profit and loss statement and cash flow statement.
  - Income Tax return with computation of Income
  - Certified copy of P.F.No. / Labor Welfare No. / Professional Tax / Labor License etc.
  - GST Certificate
  - PAN Card
  - Udyog Aadhar (MSME Registration) – If applicable
  - Details as per Annexure – I & II on firm letter head.

**SPECIFIC PQ CRITERIA SLUDGE TRANSPORTATION FROM NARMADA CLEAN TECH [NCT] - JHAGADIA TO BEIL:**

1. **SCOPE OF WORK:** Scope of work includes the loading of the sludge in dumpers along with transportation to BEIL by contractor using their own GPCB / BEIL approved dumpers.  
Preference will be given to the vendor with similar experience in large processes or chemical process or environmental process industries.
2. **TENTATIVE QUANTITY:** 1500 MT per year (Quantity as measured by BEIL will be considered for billing purpose). Average trips/monthly basis depending on requirement) failing to this will attract penalty.
3. **REQUIREMENT:**
  - The transporter should be BEIL approved for conveyance of Hazardous waste. The Transporter shall also fulfill all other statutory government / GPCB / BEIL requirements.
  - Minimum 2 Nos. of dumpers are required on the owner's / Firm name.
  - Details of dumpers owned by the agency along with ownership proof (R.C. book copy)
  - GPCB / BEIL approval letter (For all approved vehicles) to be submitted.
4. **PERIOD OF CONTRACT:** The period of the contract is for one year, which can be extended for one more additional year on mutually agreed terms and conditions.

**FINANCIAL TERMS:**

- Agency will follow all statutory compliance as per prevailing laws & NCT policy.
- The Penalty shall be applicable in case of non-fulfillment of agreed terms & conditions.
- 2.5 % S.D. (Security Deposit) will be deduct from basic value of the first R.A. Bill. And an amount of 2.5% of the work order value will have to be deposited in the form of Bank Demand Draft in favour of "Narmada Clean Tech," drawn on any Nationalized Bank payable at Ankleshwar. In case of Extension/Amendment, SD will be applicable as above. The same S.D. value (5 %) (Without any Interest) will be release after 3 months of successful work completion by contractor. If for any reason the agency regrets to work during contract period or is not capable to complete the work in contract period, the same S. D. amount will be forfeited in NCT account and no legal matter will be applicable for the S.D.

1. No any price revision is applicable up to completion of awarded contract.

3. NCT reserved rights to cancel any or whole pre-qualification process without prior intimation.
