EXPRESSION OF INTEREST & PRE-QUALIFICATION

Narmada Clean Tech (NCT) is a company, and subsidiary of GIDC engaged in the operation of the treatment facility and conveyance of treated wastewater to the deep sea. NCT invites competent and well-experienced vendors for **250KVA Online UPS with 30 minutes power backup design, supply, installation, and commissioning at Narmada Clean Tech, Ankleshwar premises with including 1-year operation and maintenance.**

GENERAL PRE-QUALIFICATION (PQ) CRITERIA FOR ISSUE OF TENDER DOCUMENTS:

1. The vendors should provide a single Work Order copy of similar work execution (Minimum 250KVA UPS) and their existing major clients. (Minimum 3 copies of work order is mandatory)
2. The vendors should have similar job experience of at least 3 years and have to submit the proof.
3. The total turnover of the vendor during the last three years should not be less than three times the estimated cost per year of the specific tender.
4. The estimate of a 2 X 250KVA Online UPS is RS-1.2 Crore approx.
5. The vendor should not have had any disputes with NCT and not have filed any legal cases against NCT Management and directors currently and during the last five years.
6. The vendors have to submit the following documents –
 - Audited and certified copy of the last three years' balance sheet
 - Profit and loss statement
 - Income Tax return with computation of Income
 - Certified copy of RPFC / PF/ ESIC /professional tax. / Labour welfare. Registration / License/Electrical contractor certificate/GEDA approval certificate etc.
 - Service Tax / GST details
 - PAN Card
7. Litigation history

Bidder should provide information on any history of litigation or arbitration resulting from contracts executed in last five years or currently under execution.

SPECIFIC ELIGIBILITY CRITERIA

The contractor should have proven capability of a minimum **250KVA Online UPS with 30 minutes power backup design, supply, installation, and commissioning at Narmada Clean Tech, Ankleshwar with including 1-year operation and maintenance.**

1. The proof of work completion certificate will be submitted to NCT
2. The vendor/Contractor should be approved by state and central government statutory authorities.

FINANCIAL CRITERIA

- i) The agency will follow all statutory compliance as per the NCT policy. ESIC applicable at NCT hence agency will be obey all the rules and regulations of ESIC during the work contract or installation.
- ii) Penalty shall be applicable in case of non-fulfillment of agreed terms & conditions.
- iii) 2.5 % S.D. (Security Deposit) will be deducted from the Bill. The same S.D. value (Without any Interest) will be released after 6 months of successful work completion by the contractor. If any reason agency regrets to work during the contract period or is not capable of completing the work in the contract period the same S. D. amount will be forfeited in the NCT account and no legal matter will be applicable for the S.D.
- iv) Work Order value will be frozen up to the completion of the entire contract. No, any price revision is applicable up to the completion of the awarded contract.
- v) Work Order cannot be transferred to any other agency or sub-contractor or any else.
- vi) NCT reserves the right to cancel any or whole pre-qualification processes without prior intimation.

TECHNO-COMMERCIAL EVALUATION only offers from Bidders meeting the specified PQ criteria shall be considered for Techno Commercial Evaluation.
