NCT invites competent and well-experienced vendors for Annual ARC worl: for repairing, servicing, and Mis. Repair of 1 phase/3 phase induction motors at NCT-Ankleshwar, NCT-Jhagadia and NCT-Kantiyajal (Booster Pumping Station).

GENERAL PRE-QUALIFICATION (PQ) CRITARIA FOR ISSUE OF TENDER DOCUMENTS:

- 1. The vendors should have similar job experience in motor rewinding and repairs of the last 5 years like 3 phase/1 phase, induction motor, submersible pumps, ceiling fans, etc.
- 2. The vendors must have work experience in highest ratting LT motor repairing or rewinding up to 315 KW.
- 3. Total turnover during the last three years should not be iss than three times the estimated cost per year. (Estimate cost for AMC/ARC is 10.0 lakhs) <
- 4. The vendor should not have had any disputes with NÇT and not have filed any legal cases against NCT Management & Directors currently and during the last five years.
- 5. The vendor has his own workshop with necessary tools and tackle related to the job.
- 6. The service or work order cannot be transferred to a sub-contractor or any joint partnership firm.

7. The vendors have to submit the following documents --

- Last 5 years (each year single order) work order signed/stamp copy including completion certificates.
- Any single work order as proof of doing work of highest ratting LT motor repair & rewinding covered 315 KW motor.
- Submit the latest authorized service center certificate from OEM.
- Submit a list mentioning Workshop detail, a list of manpower, tools and tackles, and testing instruments on your letterhead.
- Submit satisfy customer list with their contact person's name and number.
- Audited and certified copy of the last three years' balance sheet.
- Profit and loss statement
- Income Tax return with computation of Income of last three years.
- Certified copy of RPFC / PF/ ESIC /Professional Tax. / Labor welfare. Registration /ESI/ Electrical License etc.
- Service Tax / GST details
- PAN Card copy
- Declaration for litigation history, legal cases or any dispute with NCT.
